 "IT SHALL BE UNLAWFUL FOR THE OWNER, RESIDENT, TENANT OR OCCUPANT OF ANY RESIDENTIAL OR NONRESIDENTIAL STRUCTURE IN THE CITY TO PROVIDE FOR GARBAGE AND TRASH REMOVAL FOR THE PREMISES EXCEPT WITH THE AUTHORIZED OR FRANCHISED GARBAGE AND TRASH COLLECTOR OF THE CITY, IN ACCORDANCE WITH THE REGULAR COLLECTION SCHEDULE ESTABLISHED FROM TIME TO TIME BY THE COLLECTOR."
